CONSTRUCTION / CONSULTANCY FORECAST / ANALYSIS

Construction Industry Activities/ Overview

Press Conference was held by Construction Industry Alliance (CIA) on 9 February 2017 (Thursday), where our chairman Ir Francis Kung spoke on behalf of ACEHK alongside 15 other parties within the industry. Since its formation 3 years ago, CIA has been combatting filibustering at Legislative Council (LegCo) proactively.

Of the list of 43 items to be discussed in this year's LegCo meetings, totaling ~100 billion HKD, only 1 item has been approved by the Public Works Subcommittee (PWSC) after 8 of the scheduled 20 meetings. This is still awaiting adoption by the Finance Committee! Another item, the Capital Works Reserve Fund Block Allocations (HEAD 701 to 710), totaling 12.4 billion HKD (more than 9000 smaller projects), is currently still under deliberation by PWSC as of 3 Feb 2017. Continuous delays in funding approvals have serious adverse impacts to engineers, workers, and other professionals in the field.

With the threshold estimated at 200 billion HKD (at least 70 billion from public works) for sustainable development of the construction industry, it is vital that LegCo cooperates in approving public works projects for the betterment of our community and society.
