    - b) The Institution of Civil Engineers, London
    - c) The Institution of Mechanical Engineers, London
    - d) The Institution Engineering & Technology, London
    - e) The Institution of Structural Engineers, London
    - f) The Institution of Chemical Engineers, London
    - g) The Institution of Mining and Metallurgy, London
    - h) The Chartered Institution of Building Services Engineers, London
    - i) Any other professional institution applicable to the special branch of engineering in which he practices which may be approved by the Council as being, in the opinion of the Council, of high standing, or
    - j) as a Corporate Member of one or more of the institutions a) to i) above and have demonstrated to the satisfaction of the Council that he:-
      - k) has more than 10 (ten) years of relevant experience since election to corporate membership of appropriate institution,
      - l) is over 35 years of age,
      - m) has held a position of recognised responsibility for a period of at least 5 (five) years.
